### PRIVACY POLICY FOR THE LANDOWNER / OCCUPIER QUESTIONNAIRE

Dalcour Maclaren Limited, Morecambe Offshore Windfarm Limited, Morgan Offshore Wind Limited, Offshore Wind Limited, Cobra Instalaciones Servicios, Flotation Energy plc, BP and Energie Baden-Wurttemberg AG (EnBW) ("we" or "us" or "our") are committed to protecting and respecting your privacy.

This Privacy Policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Dalcour Maclaren Limited, Morecambe Offshore Windfarm Limited, Morgan Offshore Wind Limited, Offshore Wind Limited, Cobra Instalaciones Servicios, Flotation Energy plc, BP plc and Energie Baden-Wurttemberg AG (EnBW) whose registered addresses can be found at Schedule 1 below, are the data controllers of information processed under this Privacy Policy.

Please read the following carefully to understand our practices regarding your personal data and how we will treat it. By providing us with personal information through the Landowner / Occupier Questionnaire ("**LOQ**"), you are accepting the practices described in this Privacy Policy.

### 1. PERSONAL INFORMATION WE MAY COLLECT

We may collect and process the following information about you:

# 1.1 Information you give us

You may give us information about you and others by filling out the LOQ. The information you give us may include:

- 1.1.1 personal information, e.g. title and full name, address, email address, phone number (landline and / or mobile), signature;
- 1.1.2 if you are responding on behalf of an organisation (e.g. company, partnership or charity), information about your company, e.g. company name, to the extent that it comprises personal data;
- 1.1.3 if you are proposing to instruct an agent / surveyor to act on your behalf, your agent's / surveyor's details such as name and/or firm, address, telephone and email address;
- 1.1.4 information about owners and occupiers of the land, e.g. names, addresses and contact details, including of all trustees and executors if applicable;
- information about any other people or organisations who have an interest in the land, e.g. rights of access (including shared access ways), options to purchase, cautions, restrictive covenants, rent charges, public rights of way, grazing rights, shooting rights, subsoil/mineral rights, manorial rights or easements (e.g. for gas or water mains) over the land, e.g. title and full name, address, telephone, email address, nature of interest;
- 1.1.6 content and information you input in open text fields, e.g. land ownership information, land use information, special access requirements or risks; and
- 1.1.7 information you may give us when calling our land referencing team.

# 1.2 Information we collect about you

- 1.2.1 If you select to fill out the LOQ by scanning the QR code at the top of the LOQ or by visiting our website <a href="https://form.jotform.com/221992206787365">https://form.jotform.com/221992206787365</a> we may automatically collect the following information:
  - (a) technical information, including the Internet protocol (IP) address used to connect your device to the internet, browser type and version, connection type and settings, time zone settings, browser plug-in types and versions, operating system and platform, full Uniform Resource Locators (URL) clickstream to, through and from our website (including date and time);
  - (b) content you viewed or searched for, page response times, length of visits to certain pages, information in relation to the features you use and page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page; and
  - (c) how you interact on our website; and
  - (d) device identifiers, download errors and crash data and any phone number used to call our customer service number.
- 1.2.2 We may also collect anonymous and aggregated information about your visits and interactions, including page response times and errors, which we use for statistical reporting about the website. This information can no longer be associated with you.

#### 1.3 Cookies

1.3.1 We and our service providers collect information about your use of our website from cookies, beacons, tags, scripts, and other similar technologies to distinguish you from other users of the website, and to analyse trends, administer the website, track users' movements around the website, and gather demographic information about the website user base as a whole. ## 2. PURPOSES FOR WHICH WE PROCESS PERSONAL INFORMATION AND LAWFUL BASES

We make sure we have appropriate legal bases on which to collect, use and share personal information. We use personal information held about you and others in the following ways:

# 2.1 Where we have a legal obligation

2.1.1 We may use this information:

# 2.2 Where we have a legitimate interest

# 2.4 In limited circumstances, where we have your consent where necessary.

- 2.5 We will only use your information for the above purposes. We will not use such information for any other purpose.
- 2.6 If you do not provide the necessary personal information or withdraw your consent for the processing of your personal information where consent is relied on, we might not be able to carry out a contract with you or provide you with a service.

## 3. SECURITY

- 3.1 Taking into account the state of the art, the costs of implementation and the nature, scope, context and purposes of processing as well as the risk of varying likelihood and severity for the rights and freedoms of natural persons, we implement appropriate technical and organisational measures to ensure a level of security appropriate to the risk and to protect your personal data against accidental or unlawful destruction, loss, alteration, or unauthorised disclosure or access. We may use third-party products and services to secure or store your information.

## 4. SHARING PERSONAL INFORMATION

4.1 We may share personal information with any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries.

- 4.2 We may share your personal information with selected third parties including business partners, suppliers and sub-contractors for the purposes described above in section 2 of this Privacy Policy, e.g., professional advisors, cloud storage providers, accounting software platforms, etc.
- 4.3 We may also disclose your personal information to third parties:
- 4.3.1 in the event that we sell or buy any business or assets, we may disclose your personal information to the prospective seller or buyer of such business or assets;
- 4.3.2 if our assets, or substantially all of our assets, are acquired by a third party, personal information held by us may be one of the transferred assets;
- 4.3.3 if we are under a duty to disclose or share your personal information in order to comply with any legal obligation, to enforce any agreements, or to protect our rights, property or safety, or the rights, property or safety of others.

#### 5. INTERNATIONAL TRANSFERS OF PERSONAL INFORMATION

- 5.1 The personal data that we collect or receive about you may be transferred to and processed by recipients which are located inside or outside the United Kingdom ("**UK**"). We will take all necessary measures to ensure that transfers out of the UK are adequately protected as required by applicable data protection law.
- With respect to data transfers to countries not providing an adequate level of data protection, we rely on appropriate safeguards, such as standard data protection clauses adopted by a relevant regulator or supervisory authority, approved codes of conduct together with binding and enforceable commitments of the recipient, or approved certification mechanisms together with binding and enforceable commitments of the recipient. - 6.1 We only keep your information for as long as is necessary for us to use your information for the purposes described above in section 2 of this Privacy Policy. However, please be advised that we may retain some of your information, for instance for our lawful record keeping purposes and where this is necessary to meet our legal obligations, such as retaining the information for tax and accounting purposes.
- When determining the relevant retention periods, we will take into account factors including:
  - (a) our contractual obligations and rights in relation to the information involved;
  - (b) legal obligations under applicable law to retain data for a certain period of time;
  - (c) our legitimate interests where we have carried out a balancing test;
  - (d) statute of limitations under applicable law(s);
  - (e) (potential) disputes;
  - (f) if you have made a request to have your information deleted; and
  - (g) guidelines issued by relevant data protection authorities.
- After such time, we will either securely erase or anonymise your information where we no longer have a legitimate reason for keeping it. If this is not possible (for example, because the information has been stored in backup archives), then we will securely store your information and isolate it from any further use until deletion is possible.

Right What does this mean?			
1.	The right to object to processing	You have the right to object to certain types of processing, including processing for direct marketing (if applicable).	
2.	The right to be informed	You have the right to be provided with clear, transparent and easily understandable information about how we use your information and your rights. This is why we're providing you with the information in this Privacy Policy.	
3.	The right of access	You have the right to obtain access to your information (if we're processing it), and certain other information (similar to that provided in this Privacy Policy).  This is so you're aware and can check that we're using your
